#### Privacy notice

Westfield Medical Practice has a legal duty to explain how we use any personal information we collect about you as a registered patient at the practice. Staff at this practice maintain records about your health and the treatment you receive in paper and electronic format.

#### Information we collect

We will collect information such as personal details, including name, address, next of kin, records of appointments, telephone calls, treatment and medications, test results, x-rays etc. and any other relevant information. relation to your care.

## How we will use your information

Your data is collected for the purpose of providing healthcare services; however, we can disclose this information if it is required by law, if you give consent or if it is justified in the public interest. The practice may be requested to support research, however, we will always gain your consent before sharing you information with medical research databases when the law allows.

Sometimes the NHS also uses relevant information about your health to help improve NHS services and public health in Scotland – for example, to find out how many people have a particular illness or disease. If so, information that identifies you is removed. If the NHS uses information that does identify you (for example to include it in a disease register) they must explain how and why your information will be used.

## Maintaining Confidentiality

WP. committed maintaining confidentiality and protecting the information we hold about you. We adhere to the General have the right to access the information General Data Protection Regulation (GDPR), the NHS Scotland Code of Practice, as well as guidance issued by the Information Commissioners Office (ICO). You have a right to access this information we hold about you and if you would like to access this information, you will need to complete a Subject Access Request (SAR) Please ask at reception for a SAR form. Furthermore, should you identify any inaccuracies, you have a right to have the inaccurate data corrected.

#### Opting out

You have the right to object to your information being shared. Should you wish to opt of data collection, please contact a member of staff who will be able to explain how you can opt out and prevent the sharing of your information. You can change your mind at any time. Your choice will not affect the care you receive from us.

#### Retention Periods

In accordance with the Records Management NHS Codes of Practice (Scotland), your healthcare records will be retained for the duration of your life and for 3 years after your death.
